**◀ DIRECTIONS TO TRIAL SITE – ADAMS COUNTY FAIRGROUNDS – HENDERSON (BRIGHTON) COLORADO:**

- **FROM 1-25 NORTH OR SOUTH:** Take I-76 East to US Highway 85. Go north on Hwy. 85 to 124<sup>th</sup> Avenue (mile marker 230). Turn left (west) on 124<sup>th</sup> Avenue. Continue west on 124<sup>th</sup> Avenue (which becomes Henderson Road after the stop sign.) Proceed straight on Henderson Road to Adams County Fairgrounds. Turn right into the Fairgrounds.
- **FROM HIGHWAY 7 –** Take Highway 7 to U.S. Highway 85. Go south on Highway 85 to 124<sup>th</sup> Avenue (mile marker 230). Turn right (west) on 124<sup>th</sup> Avenue. Continue west on 124<sup>th</sup> Avenue (which becomes Henderson Road after the stop sign.) Proceed straight on Henderson Road to Adams County Fairgrounds. Turn right into the Fairgrounds.
